She will email the group again.</p> <p>Discussion was held on a RFP on STEM. Agnes will visit the LCO Boys & Girls Club to see how their STEM program is running. Agnes looked at other Tribes, and believes the Menominee Tribe is also running a STEM program.</p> <p>Agnes left a message for Jennifer Robertson (BOTS), who was out of the office.</p> <p>Agnes has not done any work on new posters. She hasn't decided if she's two or three new posters, and is considering using images from the Youth PSA project. The topic of the Youth PSA in Milwaukee was distracted driving.
