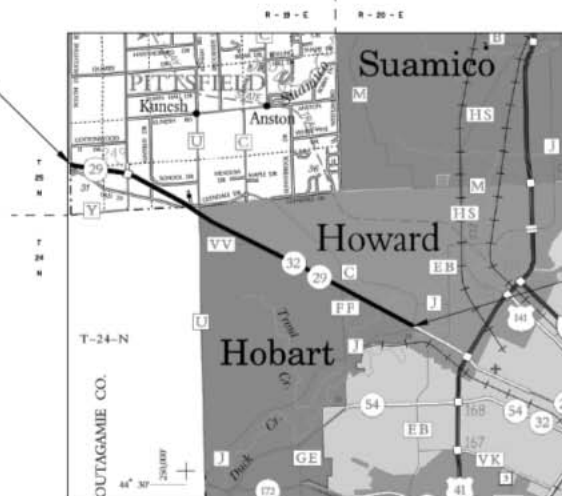

Oneida Mitigation Bank Cont...

▶ Intergovernmental Agreement

WHEREAS, the Tribe and WISDOT desire to enter this Agreement to achieve the following general objectives:

- 1) Establish a WisDOT Wetland Mitigation Bank Site on Parcels HB-643 (owned by WisDOT) and HB-644 (owned by the Tribe) pursuant to a Mitigation Bank Instrument to be executed by WisDOT with the U.S. Army Corps of Engineers (hereinafter referred to as “the Corps”).
- 2) Transfer ownership of parcel ID # HB-643 , the Oneida Wetland Mitigation Bank Site, from WisDOT to the Tribe at the end of construction of the Project,
- 3) Transfer maintenance responsibility of the Oneida Wetland Mitigation Bank Site from WISDOT to the Tribe at the end of the 10 year wetland monitoring period, with continued WisDOT maintenance responsibilities afterwards only in the event of catastrophic failure as further defined in the Project Site Plan, and as further detailed in the Mitigation Banking Instrument to be executed by WisDOT with the Corps, and
- 4) Establish protections to maintain the Oneida Wetland Mitigation Bank Site as a wetland in perpetuity and managed according to the Project Site Plan.

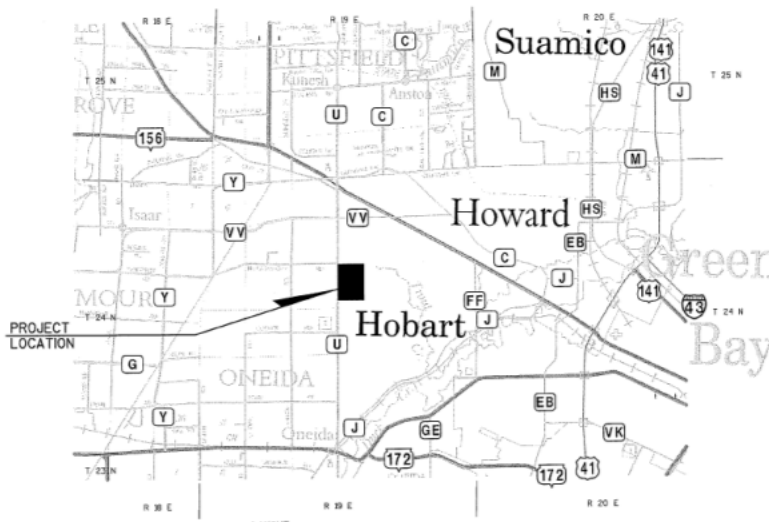
